

All publications printed at public expense for distribution to the general public must carry the cost statement, which includes the affirmative action statement. Use of these statements is a University policy. In addition, it is an Oklahoma state law that the cost be included on all publications where state money is used to print them. Please include cost statements on ANY publications that are to be distributed to the general public. Cost statements do not need to be on letterhead, correspondence, or in-house documents.

There are three different statements, one for the Oklahoma Cooperative Extension Service, one for the Oklahoma Agricultural Experiment Station, and one for general University use. Please fill in a cost—it can be a cost per piece (20 cents per copy) or a total cost (\$300 for 300 copies). The only exception to including the cost would be if using a grant from an outside agency—then it would read “at no cost to the taxpayer” (the entire statement would still be included, however). The three statements are provided below.

Also found below is a statement that must be included if pesticides are mentioned in a publication or document.

Finally below is a statement that must be included whenever a brand (other than pesticides) is included in a publication or document.
